**935** calls recorded through the **toll-free number 1523** from 28/07 to 31/12 2022 (including **303** cases of denunciations of human rights violations, **135** requests for information and **497** nuisance calls)

2

**253** self-initiated investigations by the CHRC following allegations of human rights violations

**379** visits to detention facilities (**22 AD, 40 CE, 25 FN, 2 E, 37 LT, 34 N, 77 NW, 44 WE, 28 SO, 70 SW**)

**1239** complaints received (**49 AD, 140 CE, 11 E, 74 FN, 106 LT, 77 N, 77 NW, 34 WE, 56 SO, 291 SW, 322 Head office**)

**312** fact-finding missions conducted as part of handling alleged cases of human rights violations

A total of **30** statements were issued on African and International Human and Peoples' Rights Days, and **3** International Days were celebrated with activities on the field (International Women's Day on 8 March in Maroua; International Day of Persons with Disabilities on 3 December in Yaounde, Bafoussam, Dschang and Kouoptamo as well as the International Human Rights Day on 10 December in the East, Littoral, North-West and West Regions), **9** press statements published on human rights issues in Cameroon

**16** audiences granted by the Chairperson of the CHRC to officials of State administrative services (MINEPAT and ELECAM (two), members of the diplomatic corps accredited to Cameroon (four), foreign delegations (five), CSO delegations (five) and **9** audiences granted to the CHRC by various authorities (PM, SG/PM, MINEPAT, Director General of IRIC, Director General of ELECAM, an Ambassador, the Resident Coordinator of the UN system in Cameroon, Country Director of Plan Cameroon and Director General of SOPECAM)

**29** activities organised by the CHRC involving the Human Rights Focal Points of State administrations (**20** workshops organised on human rights concepts, **7** fact-finding missions and **2** sessions capitalising on experience gained)
